The Agency will be holding an information session for its **2012 PennHOMES/Low Income Tax Credit Programs** on **Thursday, September 15, 2011**. The purpose of this session is to provide updates to our 2012 Programs and review and discuss the 2012 Selection Criteria. We strongly suggest all prospective applicants attend this briefing.

In 2012, PennHOMES and Tax Credits will be awarded in one cycle. The application for the 2012 cycle will be due on **October 12, 2011**. The announcement of funding for this cycle is anticipated to be in April 2012.
