# Governor Wolf announces funding for three New Markets Tax Credit projects

Governor Wolf recently announced that Commonwealth Cornerstone Group (CCG) has completed three New Markets Tax Credit transactions. The first, announced in October, was for \$8 million to rehabilitate a former automotive dealership site into a mixed-use retail shopping center in Reading. The second, announced in November, was for \$9 million with PATH (People Acting to Help) to renovate a historic building in Philadelphia so it can centralize its operations. A new building will also be constructed on an adjacent lot as part of the project.

The third, and most recent, was for \$7 million with the Scranton Counseling Center (SCC) to help fund the adaptive reuse of a historic cornerstone building in downtown Scranton. The rehabilitated building will be the site of SCC's behavioral health



clinic and administrative offices, as well as a pharmacy and primary health clinic to provide support services for the clinic's clients. The center's list of programs includes such things as psychiatric evaluations, 24-hour crisis intervention, community- and school-based behavioral health teams, and drug and alcohol treatment services. The structure will be renovated to provide much-improved functionality for the center's programs and staff.

The goal of CCG, through its administration of New Markets Tax Credits, is to fund projects in key areas of communities that have historic or cultural value and offer opportunities to spark economic revitalization. CCG utilizes these tax credits to provide loans and equity investments for business expansion, mixed-use development, and community facilities across Pennsylvania.

### FHLBank Pittsburgh and PHFA announce Home4Good funding awards

In mid-November, FHLBank and PHFA announced the 2019 Home4Good funding awards to reduce homelessness across Pennsylvania. This is the second year for this joint initiative, with FHLBank Pittsburgh providing \$3 million and PHFA providing \$1.5 million each year.

The Home4Good program funding is distributed as grants to organizations that help individuals find or retain housing, provide services to those facing homelessness or address other unmet needs within the existing homeless provider network.

Some of the accomplishments under his leadership include changes to the agency's homeownership programs to meet evolving consumer needs, the allocation of hundreds of millions of dollars of tax credit investments in affordable rental housing across the commonwealth, and the expansion of a statewide housing counseling network. # 2020 PHFA Housing Policy Fellow named

PHFA has named Rachel Fawcett as its inaugural housing policy fellow. Fawcett will receive a financial stipend of up to \$12,000 during 2020 to conduct research benefiting the affordable housing industry. In the process, she will gain valuable experience aiding her professional development.

Fawcett's fellowship project will focus on research into community land trusts across the country to determine their viability as a shared-equity housing model. Community land trusts have been undertaken by some communities to help meet the overwhelming demand for affordable housing. Her research will assess the concept, explore how it is currently being applied, and offer recommendations for future initiatives in Pennsylvania.
