PHFA issues RFP for PHARE funding to support local housing initiatives

PHFA has issued a Request for Proposals soliciting applications from organizations for projects to improve the availability and affordability of housing across the commonwealth. Funding for this RFP is being provided through the Pennsylvania Housing Affordability and Rehabilitation Enhancement (PHARE) Fund. The total PHARE funding available this year exceeds \$45 million.



PHARE applications are completed and submitted entirely online, eliminating the need for paper submissions and simplifying the process for applicants. The RFP is located on <u>PHFA's website</u>, and the application is accessible on the <u>PHARE</u> webpage. Applications are due to PHFA no later than 2 p.m. on Friday, Nov. 18.

PHARE receives its funding from the impact fee levied on natural gas drilling companies and a portion of the Realty Transfer Tax. Funding is available for housing initiatives in all of Pennsylvania's 67 counties. PHFA is charged by the General Assembly with administering the allocation of PHARE dollars.

PHFA posts RFP to fund mixed-use development projects

PHFA has issued a Request for Proposals for the new construction, or rehabilitation, of mixed-use developments seeking financial support. Funding will be provided through the Community Revitalization Fund Program. Mixed-use projects combine residential and retail/commercial space in the same building and often serve as a catalyst for neighborhood revitalization. The deadline for proposal submission is 2 p.m. on Friday, Nov.4.

Eligible applicants for this funding include units of local government (counties, cities, boroughs, etc.); redevelopment authorities; for-profit firms; non-profit groups; and economic development organizations. Applications from third-class cities will be given higher priority in this year's proposal evaluations. Information about the Community Revitalization Fund RFP is posted on the <u>PHFA website</u>. PHFA streamlines its procurement process

In an effort to improve its procurement process, PHFA has joined the Pennsylvania Purchasing Group. As a result, beginning Sept. 1, the agency has been publishing and distributing bid opportunities on the bidnet direct system available via the Web. PHFA is using the bidnet direct system to streamline its purchasing process, including bid management, bid distribution and vendor relations. Bidnet direct's Pennsylvania Purchasing Group connects participating agencies from across Pennsylvania and is a single, online location for managing sourcing information and activities. It provides the tools needed to have a compliant, transparent bid process while minimizing the agency's costs and saving time. (Cont.) Registered vendors can access open bids, related documents and files, additional addendum, and award information. Additionally, the broader Pennsylvania Purchasing Group offers a value-added service by notifying vendors of new bids targeted to their industry, all addenda, and advance notification of expiring term contracts. Pennsylvania Homeowner Assistance Fund team attends community outreach events



The Pennsylvania Homeowner Assistance Fund, or PAHAF, had staff on site at several pop-up PAHAF outreach events in August in communities around the state.

PAHAF, administered by PHFA, is a housing-related program funded by the U.S. Department of the Treasury to assist Pennsylvnia homeowners facing financial hardship due to the COVID-19 pandemic. The program was established through the 2021 Americacn Rescue Plan and provides financial assistance to address mortgage delinquencies and avoid default, displacement, and foreclosure for eligible Pennsylvania homeowners experiencing financial difficulties due to the coronavirus pandemic.

PAHAF staff was able to answer questions, provide information, and help homeowners start the application process.
