A meeting of the Members of the Board of the Pennsylvania Housing Finance Agency, which offices are located at 211 North Front Street, Harrisburg, Pennsylvania, was held on Thursday, March 14, 2024, at 10:30 a.m. both in person and via conference call.

In compliance with the provisions of the Sunshine Act, notification of this meeting appeared in the Legal Notices Section of *The Patriot News* in Harrisburg, Dauphin County on March 10, 2024.

1. CALL TO ORDER AND ROLL CALL

The meeting was called to order by Chair Spicher at 10:38 a.m. The roll was called, and a quorum was present.

2. APPROVAL OF THE MINUTES FROM THE FEBRUARY 8, 2024 BOARD MEETING

Mr. Pandeladis indicated there is a correction to the February 8, 2024 Board Meeting Minutes as presented. Board member, Markita Morris-Louis, participated remotely at the February 8, 2024 board meeting.

Chair Spicher asked for a motion to approve the minutes from the February 8, 2024 Board Meeting as presented. This motion was made, seconded and was unanimously approved.

Chair Spicher also asked for a motion to approve the February 8, 2024 board meeting minutes as amended. This motion was made, seconded and was unanimously approved.

3. RECOGNITION OF STAFF

Director Wiessmann recognized the retirement of Angela Harris-Reider, Accountant, with 25 years of service. Director Wiessmann indicated Ms. Harris was unavailable for the meeting but had provided a note of appreciation for the acknowledgement of her years of service.

Mr. Carl Dudeck, Director of Housing Management, was recognized for his 40 years of service. Acknowledgements were offered by Mr. Kurt Livering, Ms. Lisa Case, and Ms. Jessica Perry as well as Director Wiessmann and Members of Agency's Board. Mr. Dudeck expressed his appreciation for his five outstanding managers who help make his job easier and who also strongly believe in Agency's mission statement.

4. PROGRAM AND DEVELOPMENT REVIEW (PDR) COMMITTEE REPORT

Mr. Christiano reported the PDR Committee had an opportunity to review the following proposals carefully, and concurs with staff's recommendations.

A. Request for Commitment of First Mortgage Financing

i. Abigail Pankey Apartments

Ms. Perry presented the Abigail Pankey Apartments proposal for first mortgage financing. The project is located in Philadelphia, Philadelphia County. Staff is recommending approval, contingent upon the conditions outlined in the resolution.

A motion was made and seconded that the Board approve the resolution, with conditions, authorizing the request for first mortgage financing regarding Abigail Pankey Apartments. Mr. Schwartz abstained. Motion carried with abstention.

ii. Gaudenzia West Mill Place

Ms. Perry presented the Gaudenzia West Mill Place proposal for first mortgage financing. The project is located in Philadelphia, Philadelphia County. Staff is recommending approval, contingent upon the conditions outlined in the resolution.

A motion was made that the Board approve the resolution, with conditions, authorizing the request for first mortgage financing regarding Gaudenzia West Mill Place. This motion was seconded and carried unanimously.

iii. HELP Philadelphia I & II

Ms. Perry presented the HELP Philadelphia I & II proposal for first mortgage financing. The project is located in Philadelphia, Philadelphia County. Staff is recommending approval, contingent upon the conditions outlined in the resolution.

A motion was made that the Board approve the resolution, with conditions, authorizing the request for first mortgage financing regarding HELP Philadelphia I & II. This motion was seconded and carried unanimously.

iv. Ruth Street Civic House

Ms. Perry presented the Ruth Street Civic House proposal for first mortgage financing. The project is located in Philadelphia, Philadelphia County. Staff is recommending approval, contingent upon the conditions outlined in the resolution.

A motion was made and seconded that the Board approve the resolution, with conditions, authorizing the request for first mortgage financing regarding Ruth Street Civic House. Mr. Schwartz abstained. Motion carried with abstention.

B. Other Business

Mr. Christiano also reported that the PDR Committee was apprised of two information updates.

i. Disposition of Properties

Director Wiessmann reported that the Agency is continuing its efforts to seek enhancement options for the properties previously discussed. Mr. Dudeck concurred and added that Housing Management staff are being very proactive with exploring options to keep the properties as affordable housing stock.

ii. Multifamily Calendar

Ms. Perry reported that the Agency received nineteen (19) 4% tax credit applications by the submission deadline of February 29, 2024. She is hopeful to announce the awards by the end of Summer 2024.

5. HOUSING RESOURCES UPDATE

A. Single Family Loan Production Update

A single family loan production update was provided by Director Wiessmann. She indicated there continues to be an enormous demand for our mortgage loan programs.

B. Multifamily Production Update

Ms. Perry provided additional notes on the Agency's multifamily portfolio.

6. LEGISLATIVE UPDATE

Ms. Grover provided a legislative update. Director Wiessmann acknowledged Ms. Grover for coordinating the various meetings and preparing an informational packet for the legislative members during the NCSHA Legislative Conference held earlier this month.

7. OTHER BUSINESS

A. 2024 Housing Forum – May 1 and 2, 2024

Director Wiessmann reminded the Board that the Agency's Housing Forum is scheduled for May 1 and May 2 at the Harrisburg Hilton. The theme for this year's Housing Forum is "Connections". It begins on May 1 with lunch at 12 pm; offers 23 educational sessions, an awards ceremony recognizing affordable housing innovators and more. The conference will conclude after lunch on May 2.

B. PA HAF Update

Ms. Burky provided an update on the PA HAF program. She indicated the Agency will start accepting new applications on March 18; the program dashboard will offer real-time updates of the application status.

8. ECONOMIC MARKET UPDATE

Mr. Mitch Gallo with RBC Capital Markets provided an economic market update. He offered an update on various market factors.

9. PUBLIC COMMENTS

Mr. Pandeladis indicated the Agency advertised appropriately under the Sunshine Act and there were public comments received by the participation deadline. Mr. Dave Slinger, from Gaudenzia Foundation, Inc., and Nicole Westerman, of New Kensington Community Development Corporation, each offered their appreciation to the Agency's Board and Agency staff for their efforts to keep housing affordable in the Commonwealth. Each provided statistics of current rental prices and income limits of potential tenants for their areas.

10. ADJOURNMENT

There being no further business to present to the Board, a motion was made and seconded to adjourn the Board Meeting. The motion was unanimously approved. The meeting adjourned at 12:11 p.m.
