A meeting of the Members of the Board of the Pennsylvania Housing Finance Agency, which offices are located at 211 North Front Street, Harrisburg, Pennsylvania, was held on Thursday, December 11, 2025, at 10:30 a.m. via conference call. The meeting was fully remote with no physical meeting space provided. All attendees participated via remote means.

In compliance with the provisions of the Sunshine Act, notification of this meeting appeared in the Legal Notices Section of *The Patriot News* in Harrisburg, Dauphin County on December 7, 2025.

**1. CALL TO ORDER AND ROLL CALL**

The meeting was called to order by Chair Spicher at 10:40 a.m. The roll was called, and a quorum was present.

**2. APPROVAL OF THE MINUTES FROM THE NOVEMBER 13, 2025 BOARD MEETING**

There were no additions or corrections to the minutes as presented.

**Chair Spicher asked for a motion to approve the minutes from the November 13, 2025 Board Meeting. This motion was made, seconded and was unanimously approved.**

**3. RECOGNITION OF RETIREES**

Director Wiessmann recognized the following staff on upcoming retirement Lisa Case, Housing Management, with 22 years of service; Kim Boyer, Technical Services Division with 26 years of service; Brian Good, Loan Servicing Division, with 25 years of service; and Willie Hicks, Information Technology Division, with 8 years of service.

#### **4. POLICY COMMITTEE REPORT**

Chair Spicher reported that the Policy Committee met to discuss the 2026 draft PHARE plan. The 2026 draft PHARE Plan, will be published in the Pennsylvania Bulletin in accordance with the statute seeking public comment. The public comment period will be open to allow for a 45-day comment period.

#### **5. PROGRAM AND DEVELOPMENT REVIEW (PDR) COMMITTEE REPORT**

Mr. Christiano reported the PDR Committee had an opportunity to review the following proposals carefully and concurs with staff's recommendations.

##### **A. Transfer of General Partner**

###### **i. Concord Pointe**

Mr. Livering presented the request for transfer of general partner interests for Concord Pointe. The project is in Glen Mill, Delaware County. Staff is recommending approval, contingent upon the conditions outlined in the resolution.

**A motion was made that the Board approve the resolution, with conditions, authorizing the transfer of general partner interests regarding Concord Pointe. This motion was seconded and carried unanimously.**

###### **ii. Ambler Plaza**

Mr. Livering presented the request for transfer of general partner interests for Ambler Plaza. The project is in Ambler, Montgomery County. Staff is recommending approval, contingent upon the conditions outlined in the resolution.

**A motion was made that the Board approve the resolution, with conditions, authorizing the transfer of general partner interests regarding Ambler Plaza. This motion was seconded and carried unanimously.**

##### **B. Request for Commitment of First Mortgage Financing**

###### **i. Evan Owen Apartments**

Ms. Perry presented the Evan Owen Apartments proposal for first mortgage financing. The project is in Berwick, Columbia County. Staff is recommending approval, contingent upon the conditions outlined in the resolution.

**A motion was made and seconded that the Board approve the resolution, with conditions, authorizing the request for first mortgage financing regarding Evan Owen Apartments. Mr. Schwartz abstained. Motion carried with abstention.**

###### **ii. Henley Lofts**

Ms. Perry presented the Henley Lofts proposal for first mortgage financing. The project is in Adams Township, Butler County. Staff is recommending approval, contingent upon the conditions outlined in the resolution.

**A motion was made and seconded that the Board approve the resolution, with conditions, authorizing the request for first mortgage financing regarding Henley Lofts. Mr. Lenker abstained. Motion carried with abstention.**

**C. Request for Tax Exempt Financing**

**i. Philadelphia Preservation 4%**

Ms. Perry presented the Philadelphia Preservation 4% proposal for tax-exempt financing. The project is in Philadelphia, Philadelphia County. Staff is recommending approval, contingent upon the conditions outlined in the resolution.

**A motion was made and seconded that the Board approve the resolution, with conditions, authorizing the request for tax exempt financing regarding Philadelphia Preservation 4%. Mr. Paone abstained. Motion carried with abstention.**

**D. Other Business**

There was no other Committee business to be brought before the Members of the Board.

**6. HOUSING RESOURCES UPDATES**

Director Wiessmann provided a housing resources update. Ms. Perry provided a multifamily portfolio update.

Mr. Maretzki announced the recipients of the 2026 Kathy A. Possinger Housing Policy Fellowship Award. This is the sixth round of the Fellowship. This year, the Agency has selected Evaine Sing and Zachary Phillips.

**7. AGENCY PROGRAM FUNDING FOR 2026 CALENDAR YEAR**

Director Wiessmann presented the Agency's program funding for 2026. Funding is being provided to housing counseling, downpayment/closing cost assistance, Home4Good, and ReCLAIM.

**A motion was made and seconded that the Board approve the Agency Program Funding for 2026. This motion was carried and unanimously approved.**

**8. TENTATIVE BOARD MEETING DATES FOR 2026 CALENDAR YEAR**

Director Wiessmann presented the 2026 Board meeting dates. Board meetings are typically held the second Thursday of each month at 10:30 a.m.

**9. PUBLIC COMMENTS**

Mr. Pandeladis indicated the Agency advertised appropriately under the Sunshine Act and no public comments were received by the participation deadline.

**10. ADJOURNMENT**

There being no further business to present to the Board, a motion was made and seconded to adjourn the Board Meeting. The motion was unanimously approved. The meeting adjourned at 11:11 a.m.
