### PHFA issues PHARE/RTT RFP to fund housing initiatives

PHFA has released a request for proposals (RFP) soliciting applications from organizations for projects to improve the availability and affordability of housing across the Commonwealth. The RFP will use funding made available through a portion of the Realty Transfer Tax (RTT), and organizations from across the state are encouraged to apply.

This new RFP builds on the success of the Pennsylvania Housing Affordability and Rehabilitation Enhancement (PHARE) fund, which receives a portion of the impact fees collected from natural gas companies operating in the state. Since 2012, the PHARE program has used that funding to support wide-ranging housing initiatives. But that funding could only be used to assist projects in counties that have working natural gas wells. This new RTT-based funding can be used to support projects in any of the state's 67 counties. The PHARE fund is often referred to as the state's Housing Trust Fund.

Act 58 of 2015 provides revenue from the RTT to provide money to the PHARE fund. Governor Tom Wolf signed it into law in November 2015. This first year of RTT funding allocated through PHARE will make \$12.67 million available for housing developments and programs.

The deadline to submit funding applications is January 13. Proposals will be evaluated by PHFA staff and presented to the agency's board of directors for approval in April.

## Governor Wolf announces funding for housing throughout the Marcellus Shale region

Governor Wolf and PHFA announced that its board has approved \$6.2 million for 40 housing projects to improve the availability and affordability of housing in 29 counties.

These projects are being supported by the Pennsylvania Housing Affordability and Rehabilitation Enhancement (PHARE) fund, which is administered by PHFA and funded by the 2012 Act 13 impact fee on natural gas producers.

Award recipients were approved during PHFA's October board of directors meeting.

## Fair Housing Act

### New HUD guidance on Fair Housing Act protection for people with limited English proficiency

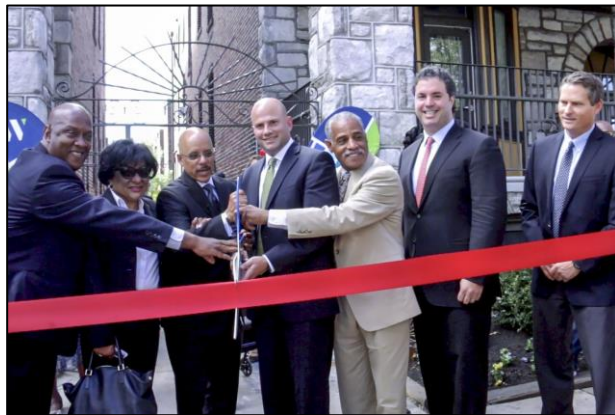
The U.S. Department of Housing and Urban Development (HUD) recently issued guidance regarding the applicability of the Fair Housing Act (FHA) to a housing provider's consideration of a person's limited English proficiency (LEP). LEP refers to a person's limited ability to read, write, speak or understand English. Although LEP individuals are not a protected class under the FHA, there is a close connection between LEP and national origin, which is a protected class under the FHA. Because a person's primary language usually derives from his or her national origin, the FHA prohibits housing providers from using an individual's LEP as a basis for an adverse housing decision. A housing provider can violate the FHA by either intentionally discriminating against people with LEP or using LEP in a way that causes an unjustified discriminatory effect. PHFA spent this fall at ribbon-cuttings and grand opening ceremonies across Pennsylvania.

He is joined by Heather Huot, senior project developer and archdiocesan coordinator for Catholic Campaign for Human Development. The development will be a 52-unit affordable housing facility for seniors. It will boast a Wellness Center, which earned it a Low-Income Housing Tax Credit (LIHTC) Innovation in Design award from PHFA. The building will also meet Passive House design standards. The project was funded, in part, by LIHTCs administered by PHFA.



WinnCompanies held a ribbon cutting ceremony in late September to celebrate the completion of Breslyn House in Philadelphia. Along with other officials, Philadelphia Councilwoman Jannie Blackwell (second from left), Senator Vince Hughes (third from left, and PHFA's Dave Doray (far right) were in attendance. Breslyn House consists of 48 two-bedroom units and 12 three-bedroom units. Thirty of these units are set aside for people with household incomes less than 50 percent of Area Median Income (AMI) and 30 units are set aside for residents below 60 percent AMI. The development was funded, in part, by Low-Income Housing Tax Credits administered by PHFA.

Tri-County Patriots for Independent Living held a ribbon-cutting ceremony in mid-August in Jefferson to unveil the new Independence Place, a four-unit apartment building for people with disabilities. The doorways and hallways are a little wider, the light switches are a little lower on the wall and there are no steps in the two ground-floor apartments, which make the units more accessible. The building was constructed with a loan and grants from the Pennsylvania Housing Affordability and Rehabilitation Enhancement Fund (administered by PHFA) and the Pennsylvania Developmental Disabilities Council.
