Bids now being accepted for \$4.5 million in tax credits

PHFA is now accepting bids for the purchase of \$4.5 million in mixed-use development tax credits. The funds collected from successful bidders will be used for the construction or rehabilitation of mixed-use developments in Pennsylvania communities. The deadline for bids is July 18. These tax credits will be used by the winning bidders to reduce their state tax liability. The bidders can be companies, organizations, or individuals. The intent of the bidding process is to raise as much funding as possible from the \$4.5 million in tax credits being made available to provide for a significant

communities. The projects to receive this funding will be selected during a competitive Request for Proposals process later this year.

PHFA publishes new Placed-in-Service package

In early May, PHFA posted on its website a revised and streamlined Placed-in-Service package. Developers who work on multifamily developments funded by PHFA should make note of this new package. The revised version will expedite the preparation process and the review process.

The Placed-in-Service package is a submission of all costs associated with a project and is certified by an accountant. It's submitted once a Low-Income Housing Tax Credit development is complete. PHFA reviews all costs and sources in the Placed-in-Service package before issuing an IRS Tax Form 8609, which is the document that finalizes the LIHTC amount for each development. The investor then uses this form to claim the tax credit.

Developers are advised to go to the <u>agency's website</u> and look for the link labeled "Placed-in-Service Package (updated 4/2025)" under the section "Tax Credit Submission Requirements and Information." They're asked to begin using this updated package immediately.

After June 30, any Placed-In-Service Packages received by PHFA must be in the new package format. For questions, please contact the Manager of the Tax Credit Program Chrissi Gerbig at (717) 780-3824.

HOUSING POLICY FELLOWSHIP

PHFA now accepting applications for the 2026 Housing Policy Fellowship

PHFA has opened the application period for its 2026 Kathy A. Possinger Housing Policy Fellowship. The fellowship was created to fund critical research and to promote leadership development.

The fellowship funds a maximum of 12 months of research on a pressing housing or community development topic by two policy fellows. A monthly stipend of \$1,000 is provided, with a maximum of \$12,000 per researcher. This financial support can be used for a variety of activities supporting the approved research, including interviews with experts, securing resources and study materials, and travel for attending relevant conferences.

To apply for the fellowship, visit the <u>agency's website</u>. All legal residents of the state over the age of 18 are eligible to apply, excluding PHFA staff and board members. All applications will be reviewed by PHFA staff according to the fellowship criteria, which are outlined on the <u>website</u>. The deadline for applying is 5 p.m. on Friday, August 1. The fellowship was named for Kathy Possinger, who was a leading affordable housing advocate who served Pennsylvanians for two decades through her work in both the public and private sectors. Her service included contributions to PHFA as a board designee and advocate.

PHFA honors its top lenders for 2024



PHARE has joined Mural Arts Philadelphia to help fund a mural project throughout Philadelphia. The project not only will beautify Philadelphia neighborhoods but will also bring community members together through the creative process.

This PHARE funding was crucial in bringing four main murals to the Sharswood. Southwest Philadelphia, Sanctuary Farm, and Ann Thomas Apartments communities. As the murals were coming

In early May, Project HOME celebrated the completion of renovations to Kate's Place in center-city Philadelphia. It is the largest supportive housing residence in Pennsylvania offering 144 efficiency apartments to individuals who have experienced homelessness, or are at risk of homelessness, as well as low-to-moderate-income residents. It also offers on-site services for all occupants promoting growth, stability and personal progress. PHFA's Executive Director and CEO Robin Wiessmann spoke during the event (bottom photo) and was on hand (top photo, third from left) along with other officials to join in the celebration.

In late June, NFL legend LeSean McCoy and his company Vice Capital held a ribbon-cutting for the new JMB Gardens in mid-town Harrisburg, which is his hometown. The new development consists of four buildings providing 41 rental units, six of which are accessible. All of the units offer rents for people with incomes ranging from 20 to 60 percent below the Area Median Income. The development will be offering supportive services to the residents, as well.





Bethlehem Haven, Pittsburgh Mercy and Action Housing are joining forces to bring Uptown Flats to uptown Pittsburgh. The groundbreaking event was held in late 2024. Once complete, the new community will offer 34 affordable housing units to residents who are exiting homelessness, have accessibility needs and are working towards becoming self-sufficient. The new community will also provide supportive services offered by Bethlehem Haven.
